Biosecurity update: treatment standards and fruit fly trial

MPI is seeking final feedback on the draft Treatment Standard: Treatment Provider Requirements following earlier consultation, which is relevant to both imports and exports. Biosecurity treatments for exports can include kiln-drying/heating, freezing/cold, preservative, and chemical dipping. Submissions are being accepted until 7 December 2022 and more information can be found here. Submissions are also still being accepted on amendments to the import health standards for fresh table grapes until 12 December 2022 and for fresh lychee until 7 December 2022.

In other news, a high-tech fruit fly trap is being trialled in Auckland following an expensive operation to prevent the spread of the Queensland fruit fly. You can read MPI's media release about the trial here.



Declining US beef production creates opportunity, but for who?

The US – the world's second-largest importer of beef after China – is likely to be looking for even more beef from global markets over the next three years, as its own domestic production declines, Rabobank says in a newly-released report. And – while New Zealand is among the major global beef exporters that could help fill the gap – its own supply constraints mean it will be challenged to find additional export volumes.

In its Q4 Global Beef Quarterly, the specialist agribusiness bank says while the reduction in the size of the US cattle herd is "nothing new" – with numbers declining rather than building in recent years – it has, to date, not impacted the amount of domestically-produced beef reaching US consumers. But that is expected to change soon, with the bank forecasting the tipping point to be reached in 2023, when US beef production should fall by 3%, with annual declines of 2-5% possible into 2026. Using perennial plants to reduce herbicide use

Herbs and forage species have been planted under apple trees in a Nelson orchard to establish if they will out-compete weeds and in doing so, reduce the use of herbicide sprays. The trial, termed *Ground cover plants to replace the weed spray strip*, is one of 12 projects to gain funding from the Rural Professionals Fund established in 2020 by the *Our Land and Water* National Science Challenge to support projects that could lead to significant improvements in farming systems and benefit farming communities. AgFirst, Willisbrook Orchard, New Zealand Apples & Pears Inc (NZAPI) and Plant & Food Research Ltd in Motueka, are all involved in the trial. HortNZ, 23 November

Aus uptake to beef agtech more 'evolution than revolution'

A new study has found that the agtech revolution is slower than hoped for the northern Australian beef industry, with valuable insights revealed into how developers should work with farmers to drive change. The CSIRO report, 'Insights on technology adoption and innovation among northern Australian beef producers', revealed a lack of engagement with researchers and tech developers despite a strong desire by producers to work collaboratively to ground truth research and ensure new tools have practical application. The report found that collaborative co-innovation approaches could assist in overcoming a lack of clear value proposition in technology, with smartphones an example. Farmers Weekly, 23 November

More live cattle forecast to be exported by sea in 2022 than 2021

The number of cattle exported by sea in 2022 looks to surpass the amount sent offshore in 2021 despite the practice being phased out. Last year a total of 134,722 cattle were exported, so far this year 95,353 have left our shores for China. A further five shipments have been given Animal Welfare Export Certificates from The Ministry for Primary Industries to export a total of 40,440 cattle before the end of the year.

China imports live cattle from countries like New Zealand to build up its own dairy herd. But last year the government announced it would ban the practice from April 2023 following a review. NZ Hearld, 22 November

Revealed: How Treasury pushed for ETS

Treasury officials repeatedly advised the government against introducing a levy and split-gas system for costing agricultural greenhouse gas emissions, arguing the sector be included in the Emissions Trading Scheme, documents reveal. The documents – released to *Farmers Weekly* under the Official Information Act – reveal that it wasn't until September that officials accepted politicians were following the He Waka Eke Noa (HWEN) process instead of their

advice. The documents also reveal that Climate Change Minister James Shaw floated the idea of a methane quota system (MQS) to price agricultural emissions and that the Treasury questioned the science behind classes of sequestering vegetation promoted by HWEN. The Treasury argued that including agriculture in the ETS was simple, would deliver strong price signals and incentivise emission reductions. <u>Farmers Weekly</u>, 21 November
